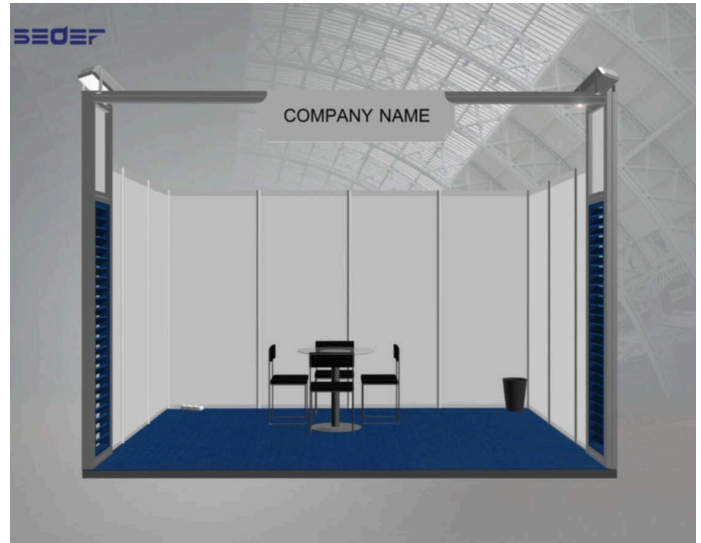

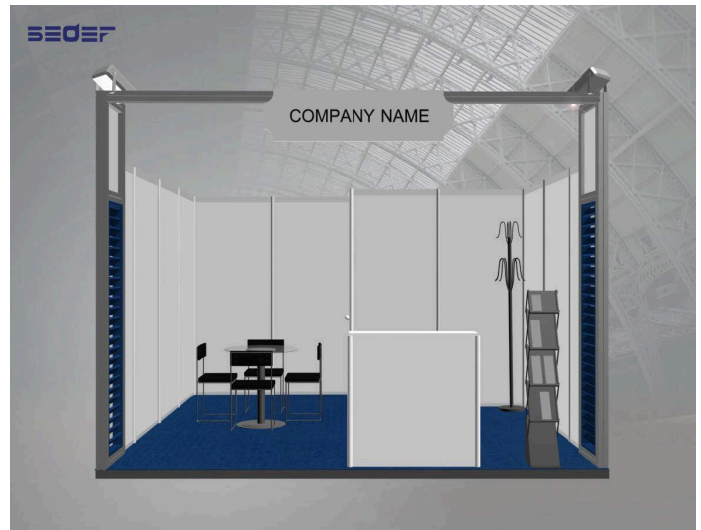

CHALETS

GENERAL INFORMATION ON STANDARD CHALETS

- Standard Chalets are provided with completed external and internal construction works, without any furniture.
- Internal and external fascia printing, installation of main power and communication lines, external dimension alterations and water inlets and outlets are subject to additional charges.
- Internal design comprising internal rooms/separation locations, power outlet spots within the chalets, door locations and alike are to be provided by the Exhibitors and the whole internal construction will then be undertaken by the Organizer's construction team so long as the requests are technically possible and the materials to be used comply with the materials provided in the standard chalet specifications given below.
- Exhibitors can undertake the internal design works through their subcontractors, should they prefer to do so.
- The basic unit, Type-A is 6m by 6m, with a 2m by 6m balcony. Standard larger modules are offered as multiples of 6m by 6m units; 6m by 12m (Type-B), 6m by 18m (Type-C) and 6m by 24m (Type-D).

STANDARD CHALET SPECIFICATIONS

- Chalet height from the ground = 60 cm.
- Internal ceiling height = 240 cm.
- Front facade : Fully glazed from floor to ceiling with 8 mm glass, jalousie and canvas awning.
- Side and rear facades : Plasterboard walls painted with Exhibitor's colour of choice.
- Front entrance door : Glass door.
- For Type A, 1m width on either side of the chalet.
- For other types, 1m or 2m double doors, on either side or in the middle of the chalet.
- Rear entrance doors : 1m width prefabricated white wooden doors on either side of the chalet. No colour option.
- Internal separators/rooms : Plasterboard with Exhibitor's colour of choice.
- Internal doors : Prefabricated 80 cm width white wooden doors. No colour option.
- Internal flooring : Laminated brown parquet.
- External flooring : Artificial green grass carpet.
- Lighting : From ceiling, with 50W halogen spotlights per 2 sqm.
- Power distribution within the chalet : 220V, single or multiple plug outlets at the locations of Exhibitor's choice.
- HVAC : 9000 BTU units per 36 sqm at the locations of Exhibitor's

2. APPLICATION

Applications are made using the Application Form,
Document-A. This Terms & Conditions Document,
Document-B is an integral part of the Application Form.

Acknowledging the terms and conditions mentioned hereafter,
the Application Form will be completed, signed, stamped and;

- emailed to application@expomint.com and
- mailed to the postal address provided in Paragraph 1.

Applications subject to conditions or reservations will not be
entertained. Every effort will be made by the Organizer to
meet Exhibitors' requests for specific spaces, yet such
requests will not be recognized as a condition for
participation.

No requests can be made by the Exhibitors with respect to the
exclusion of their competitors nor any such undertaking can
be given by the Organizer within this context.

The application is binding on the Applicant irrespective of
whether it is accepted by the Organizer or not.

The application will be considered made when the Organizer
receives the signed Application Form by email, mail or in
person.

The contract between the Organizer and the Exhibitor, under
the terms described in this document, becomes effective with
the receipt of the Application Form by the Organizer.

The Organizer reserves the right to reject any application
without stating any grounds for it.

The official deadline for application is June 30, 2022.

3. ADMISSION

The decision as to whether an entity will be permitted to
participate or its products to be displayed in the Exhibition
remains with the Organizer. The Submission of the application
does not entitle the recipient to assert any future claims
regarding its acceptance that may be denied by the
Organizer without stating any grounds. In such cases no
claims for compensation will be entertained.

The space allocation will be made to the entity indicated in the
Application Form.

The Organizer reserves the right to cancel an approved space
reservation on the basis of misleading information or if the
participation requirements are no longer met.

4. ALLOCATION OF SPACE AND ALTERATIONS

In case the requested space is not available, the Organizer
may alter the location, slightly reduce or increase the stand
size.

The Organizer reserves the right to alter entrances and exits
to/from the fairground, halls and passages. In such cases, no
claims can be brought by the Exhibitor for the refund of the
agreed total.

5. EXHIBIT GROUPS

Exhibit groups are provided in the annex of the Application
Form, Document A-5.

6. PARTICIPATING FEES

All prices are to be understood net and in US Dollars.
VAT should be added to the prices indicated.
Current VAT rate is 18 %. Exhibitors will be informed of any
changes in the rate.

Exhibitors based in countries with relevant tax agreements
with Turkey, may later get a full refund for the VAT from their
own tax authorities.

6.1. RAW STAND SPACE

All non-aircraft stand spaces both indoor and outdoor are
provided in square meters.

Both indoor and outdoor stand spaces are to be understood
as 'raw space' only.

Whatever the purpose may be, any outdoor area temporarily
covered by the Exhibitor will be considered as indoor area
and will be charged accordingly.

Due to Airport Safety & Security Regulations, Exhibitors
directly or through their contractors are not allowed to build
any stand or cover any space in the outdoor area. Such
requests should be directed to the Organizer.

Minimum indoor stand space is 9 sqm.

Indoor stand space price is usd 330.-/sqm.

Minimum outdoor stand space is 25 sqm.

Outdoor stand space price is usd 50.-/sqm.

Outdoor stand space price, if covered, is usd 330.-/sqm.

6.2. TURNKEY STAND PACKAGES

Contents of the relevant Turnkey Stand Packages are covered
in Application Form Document A-3.

All Turnkey Stand Packages include the relevant space cost,
220V power connection and consumption charges.

6.3. CHALETS

Chalet prices are to be understood, as finished and unfurnished. Technical aspects and the contents of the chalets are covered in the annex of the Application Form, Document A-4.

All chalets are subject to availability and offered on a first come first served basis. In case of unavailability, a 50 % -new production- surcharge is applied to firm orders received latest on February 28, 2022.

No chalet orders are accepted after this date, if unavailable. In case of availability, latest date to place chalet orders is June 30, 2022.

Custom made chalets are available upon request. A quotation will be made by the Organizer upon the request of the Exhibitor. The deadline for ordering custom made chalets is February 28, 2022.

Due to Airport Safety & Security Regulations, Exhibitors directly or through their contractors are not allowed to build any stand nor cover any space in the outdoor area. Such requests should be directed to the Organizer.

6.4. AIRCRAFT PARTICIPATION

6.4.1. STATIC DISPLAY AREA FEES

Aircraft participation fees in the Static Display Area are calculated according to the maximum take off weight (MTOW) provided that;

- a) the aircraft exhibited are understood to be displayed in the static, meaning that they remain in their position throughout the exhibition period and that
- b) the positioning of the aircraft are determined by the Organizer.

Aircraft Static Display Area fees are as follows.

6.4.2. DEMO DISPLAY AREA FEES

Aircraft displayed in the Demo Display Area may taxi-in and out during the exhibition and positioning of the aircraft are determined by the Exhibitors, subject to availability.

Demo Display Area fees are calculated according to the area covered by the aircraft.

The Aircraft Demo Display Area Fee is usd 50.- / sqm.

6.4.3. AIRCRAFT DISPLAY FEES FOR EXHIBITORS PARTICIPATING WITH A CHALET

Exhibitors participating with a chalet;

- a) can position their aircraft in front of their chalets which is at the Demo Display Area,
- b) taxi-in and out during the exhibition, and
- c) are charged according to the MTOW of their aircraft as per the price chart provided in the above Paragraph 6.4.1. and NOT by the area covered as in Paragraph 6.4.2.

6.5. CO-EXHIBITOR FEES

A fee of usd 500.- is charged for each co-exhibitor occupying the same space allocated to the applicant entity, the Exhibitor.

7. TERMS OF PAYMENT

Payments will be made by cheque or bank transfer. Account details are provided in the Application Form Document A-2. All costs with respect to payments will be born by the Exhibitor.

7.1. APPLICATIONS MADE BEFORE 31/12/2021

50 % of the total application fee including the VAT, will be paid at the time of application and the balance before April 1, 2022.

7.2. APPLICATIONS MADE AFTER 31/12/2021

Total fee including the VAT is to be made at the time of application.

7.3. PAYMENT OF ADDITIONAL SERVICES & MATERIALS

Exhibitors are responsible for the payment of all services ordered directly and/or through their contractors. Cost of services ordered must be paid latest 60 (sixty) days prior to the opening of the Exhibition.

8. CANCELLATION AND NON-PARTICIPATION

Applications can be withdrawn within 15 business days, following the application date. In such cases, usd 250.- + VAT must be paid as a cancellation fee.

After this period the Exhibitors will not be entitled to rescind their contract nor to reduce their stand area. In such cases the participation charges will be paid in full.

The Organizer can make alternative use of unoccupied areas to improve the general appearance of the Exhibition. The parties that reserved such areas will not be released from their financial obligations.



TERMS & CONDITIONS

9. EXHIBITS & HANDLING SERVICES

Exhibits are not permitted for removal from the stands during the Exhibition. Due to safety, security and insurance reasons, only the Agents appointed by the Organizer will be permitted to handle the consignments within the fairground.

In that all offloading, loading, delivery to and pick up from the stands will be handled by the Organizer's Forwarding Agents.

In the same way, all aircraft handling within the venue will be undertaken by the Air Services Agents appointed by the Organizer.

10. SECURITY SERVICES

The Organizer will make the general security arrangements both for the indoor halls and the outdoor area. Patrolling will start the first day of the construction period and terminate the last day of the dismantling period.

Exhibitors are responsible to take all precautions and necessary security measures within their stand spaces from the start of the construction period until the end of the dismantling period.

Exhibitors may only recruit security guards from the Organizer's accredited Security Agents.

Despite the measures taken, the Organizer declines any liability for the damages to property and personal injuries.

11. TECHNICAL SERVICES

All power connections to the stands will be undertaken by the Organizer.

The works within the allocated stand space will be carried out by the Exhibitors or their appointed contractors. The name of the Contractor and its personnel must be submitted to the Organizer. Any contractor or personnel who does not pass the security clearance of the Airport Authorities will not be allowed to enter the exhibition grounds.

The Exhibitors will be responsible to take necessary precautions within their stand against power fluctuations. The Organizer will not be held responsible for losses and damages caused by the failure of power supplies.

12. CLEANING SERVICES

The Organizer will arrange for the cleaning of the general indoor and outdoor areas.

Daily cleaning of the stands before the opening hours are the responsibility of the Exhibitors.

13. INSURANCE COVERAGE

The Organizer will provide insurance for covering risks that may occur to the exhibition area. This does not include the exhibits or belongings of the Exhibitors.

Exhibitors are expected to insure their own goods and personnel against all risks including damages caused by their own personnel, contractors as well as the third parties.

The Organizer will bare no responsibility for any damage or loss of goods or harm done to any person by virtue of being or exhibiting at the Exhibition. The Organizer undertakes no responsibility for the loss, theft or pilferage of exhibits during the Exhibition.

Valuables and precious exhibits can be deposited for safekeeping under sealed packaging with the Organizer.

14. DOMESTIC AUTHORITY

Safety and Security Regulations of the Istanbul Ataturk Airport Authority and their demands thereof, are essential and fully binding for all parties involved in the Exhibition.

Other than that, the Organizer has the full authority within the entire exhibition ground for the duration of the event starting from the beginning of the construction period until the end of dismantling period.

15. RESERVES

If necessary, for reasons beyond its control, the Organizer may postpone, curtail, extend or cancel the event or change the Venue.

In such justifiable and exceptional circumstances as in all cases of force majeure and undertakings of the Turkish Government, The State Airports and Air Traffic Control Authority and other relevant State Authorities, Exhibitors are not entitled to rescind their contracts or to claim damages, nor to reduction of participation charges due to such postponement, curtailing, extension or cancellation.

No participation charges will be payable if the Organizer is not responsible for the cancellation of the event. In such cases, The Exhibitors are credited for the total sum they paid which will only be used towards participation to the next edition of the Exhibition.

16. LEGAL MATTERS

All agreements, approvals and arrangements, irrespective of their nature must be made in writing.

Exhibitors acknowledge that they participate in the Exhibition with their own free will and decision.

This contract does not entail any oral or written promise or guarantee on the Organizer's side, as to the amount or level of business and to the success of the organization.

All claims by the Exhibitors on the Organizer will be made in writing before 22:00 hours of the last day of the Exhibition. No claims will be taken into consideration afterwards.

The place of jurisdiction for all mutual business obligations is Ankara, Turkey or upon the request of the Organizer, Exhibitor's place of business.

Laws of the Republic of Turkey are binding.
